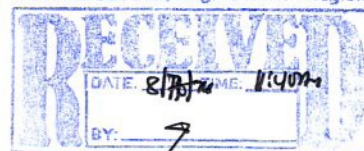

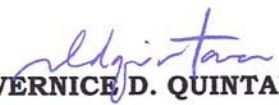

In line with the Department of Education's (DepEd) continuing efforts to ensure the effective implementation of DepEd Order No. 012, s. 2026, titled *Government Recognition of Private Basic Education Institutions Offering the Senior High School (SHS) Program*, the Private Education Office (PEO) shall conduct a **Supplemental Orientation and Implementation Check-in for private Senior High Schools (SHSs)**.

This activity is intended to provide an additional opportunity for private SHSs that were unable to participate in previous orientation activities, while also serving as a venue to clarify policy provisions, application procedures, documentary requirements, and implementation concerns raised by private SHSs.
