**ESTABLISHMENT OF THE NEGROS ISLAND REGION-REGIONAL  
SCREENING AND ACCREDITATION COMMITTEE (NIR-RSAC)**

1. Pursuant to the policies and guidelines governing regional athletic meets and in preparation for the conduct of the Negros Island Region Athletic Association Meet (NIRAAM), this Office established the Negros Island Region Regional Screening and Accreditation Committee (NIR-RSAC).
2. The Regional Screening and Accreditation Committee (RSAC) shall be composed of the following regular members:

3. Alternate members may be allowed when the regular member is not available.
4. The Schools Division Representatives shall be the Chairpersons of the Schools Division Screening Committees (DSAC) during the Division lower meets preceding the current NIRAAM.
5. The RSAC shall perform the following duties and functions:
  - a. evaluate and verify the authenticity of the athletes', coaches', and chaperons' documents before and during personal interviews;
  - b. accredit qualified athletes, coaches, and chaperons to the NIRAAM;
  - c. issue the official list of qualified athletes, coaches, and chaperons, including the corresponding identification cards (IDs), prior to the opening of the NIRAAM;
  - d. consider and act on replacements for disqualified athletes during the screening period;
  - e. formulate ground rules on matters not covered by existing eligibility guidelines;
  - f. issue athletes' photo galleries to the Tournament Managers;
  - g. re-check and monitor, in coordination with Tournament Managers, the actual fielding of athletes during competitions based on the approved photo galleries;
  - h. investigate and render decisions on protests and complaints limited to eligibility and formally inform the Tournament Manager of such decisions. All decisions shall be approved by a majority of the RSAC members; and
