1. Attached is Memorandum No. OULLA-2025-0299 dated June 24, 2025 issued by the Office of the Undersecretary for Legal and Legislative Affairs (OULLA) relative to the communications and interactions concerning the alleged irregularities in the implementation of the Senior High School (SHS) Voucher Program.

2. In line with the abovementioned issuance, all Schools Division Superintendents are directed to:

- a. prepare and submit an inventory of all pending and resolved investigations related to complaints and reports of irregularities in the SHS Voucher Program using the prescribed template (Annex A) not later than July 3, 2025 (Thursday);
- b. prioritize and submit decision-drafts for concurrence of those investigations about to commence or pending; and
- c. submit a copy of the decision along with pertinent supporting documents for confirmation of those concluded investigations with decisions rendered.
