

The Office of the Undersecretary for Curriculum and Teaching (OUCT), through the Bureau of Learning Delivery (BLD), shall conduct a series of workshops on the Development of Play-based Modules to Develop Physical Movement and Social Interaction in Key Stage 1.

This series of workshops is an innovative initiative designed to enhance the learning experience of Key Stage 1 learners by integrating play-based strategies into existing lesson exemplars. Given that the revised K-12 curriculum does not include Physical Education as a standalone subject—limiting opportunities for physical movement and social interaction mainly to MAKABANSA—this initiative seeks to address the gap by embedding structured, interactive, and movement-based activities into daily instruction. The workshops for development, validation, revision, and finalization will be attended by selected supervisors, master teachers, and school heads. To ensure continuity and consistency in the materials, the same participants should be involved throughout the development, revision, and finalization phases. Meanwhile, the orientation on utilization will be conducted for the Chief Education Program Supervisors at the regional and division levels.

Participants are required to bring their approved travel order, reference materials, laptop, and extension wires. Confirmation of attendance must be made by completing the online registration form at https://bit.ly/ELLN Play-based 2025 on or before the following deadlines:

The detailed activity matrix will be distributed on the first day of each session. Board and lodging expenses shall be charged against the 2024 ELLN Continuing Funds, while the travel expenses shall be charged against the ELLN Funds downloaded to your regions. In the event of insufficient funds, additional costs may be covered by available local funds, subject to applicable accounting rules and regulations.



FIELD VALIDATION GUIDELINES

Refined Play-Based Integration Materials for Grades 1 to 3

Teaching and Learning Division

Purpose of the Field Validation

The field validation of the Refined Play-Based Integration Materials for Grades 1 to 3 seeks to collect meaningful classroom-based insights on the effectiveness, appropriateness, and usability of the developed lesson exemplars. These lessons integrate play to foster physical movement, collaboration, and joyful learning aligned with the developmental needs of early-grade learners.

The field validation will help determine how well the materials work in real classrooms and what adjustments may be needed before their finalization.

Participating Regions and Schools

The field validation will be conducted in nine (9) schools across three regions:

Teacher Roles and Participation

Each participating school will have two levels of involvement:

1. Classroom Observation (CO)

- Select 1 to 2 teachers per school to implement a play-based lesson in an actual classroom setting.
- The teacher will be observed using a classroom observation tool.

- · Observers may be SDO focal persons, school heads, or designated master teachers.
- Observations will focus on learner engagement, instructional flow, and the play-based strategy used.

2. Desk Validation by Other Teachers

- All other Grades 1 to 3 teachers in the school will be assigned one (1) or more lesson exemplar/s to review, depending on the number of teachers and the lesson exemplars to be validated as designated by the school head or the SDO focal person.
- They will not teach the lesson but will evaluate the quality, clarity, appropriateness, and alignment of the lesson using a Validation/Evaluation Tool.
 - · This tool includes checklists and prompts for feedback and takes only about 15-20 minutes to accomplish.

Learning Areas Covered

To ensure full coverage of all content areas while making the process manageable, ALL learning areas across Grades 1 to 3 will be distributed across the 9 participating schools.

All tools are designed to be light, focused, and easy to accomplish without disrupting teachers' regular duties.

Process Flow

1. Orientation and Preparation

- · Regional and SDO focal persons will orient school focal persons and teachers on:
 - What the materials are
 - The validation objectives and workflow
 - How to use the tools and submit outputs

2. Classroom Observation and Desk Validation

- Classroom Observation will happen during a regular class schedule
- · Desk validation can be done after class or during non-teaching periods
- · Teachers will submit outputs (feedback forms, reflection notes, photo documentation) to the School Focal Person

3. Consolidation and Submission

- The School Focal Person will compile outputs and submit them to the SDO Focal Person
- The SDO Focal will forward all documents to the Regional Focal, who will submit consolidated reports to the Central Office

Recognition for Demonstration Teachers and Field Validators

To honor the valuable contributions of participating teachers, a Certificate of Recognition will be awarded to teachers who conducted classroom observation (demo teachers) and to teachers who completed the validation of materials.
