1. Consistent with this Office's ten priority projects, particularly Learners' Assessment, and in support of data-informed instructional planning, the Negros Island Region Metric for Academic Proficiency (NIRMAP) has been developed as a regional initiative to strengthen the use of localized assessment data in academic planning and school improvement efforts.
