

6. Any document such as but not limited to Deed of Donation, Deed of Sale or Contract of Usufruct for 50 years executed in favor of DepEd; Original Certificate of Title (OCT) or Transfer Certificate of Title (TCT) in the name of DepEd, reflecting the size and boundaries of the School Site	
7. Justification from the SDS in case the required size of the school site (5,000 sq. meter for rural areas and 2,500 sq. meter for urban areas) cannot be met	
8. Certified true copy of the National Certificate (NC) or diploma for the technical-vocational course attained by the School Head	
9. Certified true copy of the Certification of Training/ Participation in Rural Farm School Pedagogical Trainings and other relevant technical skills and extension services training of teachers/tutors to teach the farm school subjects.	
10. FOR ESTABLISHMENT- Clearance/Permit from the Provincial Mines and Geosciences Bureau (MGB) and the Regional Office of the Department of Environment and Natural Resources (DENR) stating that the proposed school site is not situated in a high-risk area FOR CONVERSION/ INTEGRATED- Inventory of relevant learning resources for the farm school program prepared by the school's inventory custodian and validated by the SDO	
11. FOR ESTABLISHMENT- Inspection Report from the Division In-Charge of Facilities Section, in case classrooms are already constructed FOR CONVERSION/ INTEGRATED TO FS - Updated Personal Service Itemization and Plantilla of Personnel (PSIPOP) of the concerned school

13. School building plan indicating the number and technical specifications of the classrooms to be built	
14. Certification from the SDS on the availability of teachers to teach the farm school subjects	
15. List of teaching and non-teaching personnel to be borrowed from the existing nearby schools duly certified by the SDS (if necessary)	

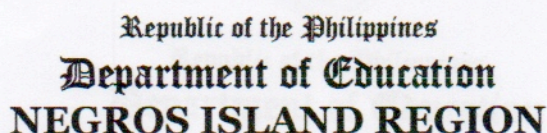

1. Map, preferably drawn to scale, showing distance of the existing schools within the catchment area of the proposed new school, duly certified by the Municipality/City Engineer	
2. Certification from the Municipality/City Engineer that the proposed farm school is not within the 30-km radius from any existing FS	
3. Justification by the SDS for the waiver on the radius requirement
