

The Department of Education issued DepEd Memorandum No. 073, s. 2025, establishing the School Innovation and Improvement Fund (SIIF). The SIIF aims to advance decentralization within the frameworks of school-based management and governance, while supporting schools in pursuing targeted interventions to improve learner performance.

For School Year 2025–2026, a total of 4,043 non-implementing public elementary and junior high schools located in 4<sup>th</sup>- and 5<sup>th</sup>-class municipalities were identified as eligible SIIF recipients. These schools received allocations from the overall budget of ₱371,653,000.00, with amounts determined based on their respective enrollment.

In adherence to existing standards on the proper management of DepEd programs, the Office of the Undersecretary for Human Resource and Organizational Development and Infrastructure (OUHRODI), through the Bureau of Human Resource and Organizational Development – School Effectiveness Division (BHROD-SED), issues the **FY 2025 SIIF Implementation Assessment Survey**. This survey aims to gather first-hand information from schools that implemented the program, ensuring that their observations, perceptions, and experiences are considered in determining the ways forward and in supporting the continuous improvement of the SIIF policy.

To guide all concerned in the mandatory accomplishment of the implementation assessment survey, the implementation arrangements are enumerated below.

**Regional Office – Field Technical Assistance Division**

1. Ensures immediate dissemination of the signed Memorandum to all concerned Schools Division Offices,
2. Directs respective Division SBM Coordinators to make sure that SIIF recipient schools receive all pertinent information, details, and deadlines, and
3. Monitor the completion rate of the SDOs using the Monitoring Tool (*See Annex B for the link*).

**Schools Division Office – School Governance and Operations Division**

1. Informs recipient schools about the mandatory participation in the implementation assessment survey,
2. Provides the online access link, ensuring all concerned school heads accomplish the form, and
3. Monitor the completion rate within its jurisdiction using the Monitoring Tool (*See Annex B for the link*).

*NOTE: For the purpose of this implementation survey, the Negros Island Region (NIR), together with its recipient SDOs and public schools, has its own set of online tools.*

**School (School Head)**

1. Provides feedback on the FY 2025 SIIF implementation through the online survey form (*See Annex A for the link*),
2. Observes the following reminders in completing the survey:
  - a. Use the DepEd personal email in accessing and accomplishing the form,
  - b. Provide the DepEd school email as one of the required survey items,
  - c. In the case of integrated schools, accomplish separate submissions for elementary and junior high, and
3. Completes the online survey **on or before April 3, 2026, Friday at 5:00 PM.**
