This Office, through the Field Technical Assistance Division in partnership with the Technical Education and Skills Development Authority (TESDA) NIR, will conduct the Regional Launching of the National Assessment Week on March 12, 2026 at Cansilayan Farm school, SDO Negros Occidental *with Simulcast views from Dumaguete City NHS, SDO Dumaguete City and Enrique Villanueva NHS, SDO Siquijor*. This assessment is aligned with DepEd's thrust to enhance the skills and competencies of SHS-TVL students, ensuring their readiness for employment or further education.
