1. The Negros Island Region Metric for Academic Proficiency (NIRMAP) is a regional initiative designed to promote the systematic use of school-level outcomes and achievement data to inform evidence-based planning and decision-making across the Negros Island Region. It ensures that student performance results are meaningfully acted upon by integrating them into School Improvement Plans (SIPs), Division Education Development Plans (DEDPs), and the Regional Education Development Plan (REDP).
2. Pursuant to its implementation, the Schools Division Offices of Negros Oriental and Siquijor provinces are hereby directed to identify and submit the list of participating schools for the conduct of the baseline data gathering.
3. The SDOs shall select schools with the capacity and readiness to administer the NIRMAP baseline data gathering, ensuring a considerable number of participating schools sufficient to generate reliable and valid data for analysis, and adequate to reflect division-wide performance and support sound statistical interpretation.
4. A representative group of learners per grade level shall be randomly selected to reflect the overall performance of the student population, ensuring reliable and valid assessment results.
5. The list of participating schools, duly endorsed by the Schools Division Superintendent, shall be submitted to the Regional Office on or before September 5, 2025 through <https://tinyurl.com/NIRMAP-SCHOOLS> using the attached template.
6. All concerned SDOs are enjoined to adhere strictly to the provisions of the guidelines to ensure the validity, reliability, and integrity of the testing process that shall be conducted on or before September 30, 2025.
