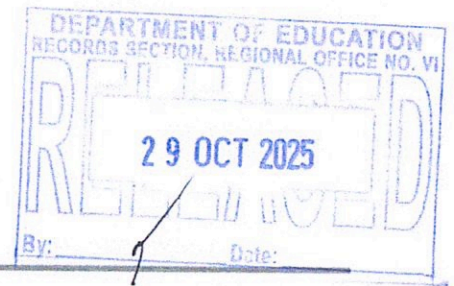

Warm greetings from the Department of Education Regional Office VI!

The National Educators Academy of the Philippines (NEAP) Region VI, a PRC-accredited Continuing Professional Development (CPD) Provider with Accreditation No. PTR-2023-419, recently received a Memorandum dated October 2, 2025, from the Professional Regulation Commission (PRC) – Continuing Professional Development Council for Professional Teachers regarding the Status of Compliance to Existing Policies and Guidelines of Accredited CPD Providers.

Based on the PRC's evaluation, NEAP Region VI has successfully implemented 107 accredited CPD programs within its accreditation period. However, 28 Completion Reports and 35 Attendance Sheets remain unsubmitted or unuploaded to the CPD Accreditation System (CPDAS).

As a result, NEAP Region VI received a compliance rating of 67.3%, which may adversely affect the renewal of its accreditation and could be considered as grounds for suspension, cancellation, or non-renewal pursuant to Section 8.2.3(c) and Section 8.2.6 of PRC Resolution No. 1032, s. 2017, otherwise known as the Implementing Rules and Regulations (IRR) of R.A. 10912 or the CPD Act of 2016.

In view of this, and to avert possible sanctions while safeguarding our authority as a PRC-accredited CPD Provider, we respectfully seek the assistance of your good Office in notifying and coordinating with the concerned Schools Division Offices (SDOs) that were formerly under the jurisdiction of Region VI but now belong to the newly created Negros Island Region (NIR).

These SDOs implemented PRC-accredited CPD programs during the period when they were still part of Region VI. Their timely submission of the remaining Program Completion Reports and Attendance Sheets will greatly help ensure NEAP Region VI's full compliance with PRC requirements.

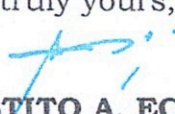
