Pursuant to the Memorandum Circular No. 106 of the Office of the President, upon recommendation of the National Disaster Risk Reduction and Management Council, work in **government offices are hereby suspended** on **Monday, 10 November 2025** in the following regions:

NCR Region II Region IV-B
CAR Region III Region V
Region I Region IV-A Region VIII

Further, classes at all levels are hereby suspended on Monday to Tuesday, 10 to 11 November 2025 in the following regions:

NCR Region III Region VI
CAR Region IV-A Region VII
Region I Region IV-B Region VIII
Region II Region V Negros Island Region

This is due to the forecasted major impacts that will be brought about by the Super Typhoon "Uwan".

However, those offices/units whose functions involve the delivery of emergency services/response, and/or the performance of other vital services shall be expected to render the services when necessary.
