- 1.0 This is to respectfully invite the Assistant School Division Superintendents to participate in the first-ever Fiscal Year (FY) 2025 Department of Education Classroom Summit to be held on 20 November 2025, from 8:00 AM to 5:00 PM at Clark, Pampanga.
- 2.0 This landmark event will gather around 1,000 participants composed of DepEd officials, partner agencies, civil society organizations, private sector partners, development partners, and contractors to exchange insights and strategies for addressing classroom shortages. Participants will have the opportunity to:
 - a. Explore the prototype of standard classrooms and upgraded temporary learning spaces, and share ideas for creating safer and more inclusive schools:
 - b. Set-up booths and showcase services and innovations;
 - c. Witness the launching of the DepEd Strategic Inventory for Deployment Efficiency — a cloud-based monitoring platform developed by the Bureau of Human Resource and Organizational Development under the leadership of Undersecretary Wilfredo E. Cabral, which tracks the progress of classroom construction projects nationwide; and
 - d. Take part in the launching of DepEd's Pledge of Commitment to a Maayos, Mabilis, Malinis na Procurement.
 - e. Join plenary and breakout sessions on DepEd's classroom programs, key strategies, and implementation requirements to support the delivery of safe and adequate learning spaces.
