**LEARNING AND CONTINUITY INTERVENTIONS ON THE DAMAGES
BROUGHT BY TYPHOON TINO**

TO: Schools Division Superintendents of Bacolod City, Bago City, Cadiz City, Canlaon City, Escalante City, Guihulngan City, Himamaylan City, La Calota City, Negros Occidental, Negros Oriental, Sagay City, San Carlos City, Silay City, Sipalay City, Talisay City, Victorias City
All Others Concerned

1. In view of the impact of Typhoon Tino to various areas in the Negros Island Region, this Office directs all the affected SDOs to conduct the following:

A. Organize Clustered Schools Division Teams

The teams shall consist of Education Program Supervisors, Public Schools District Supervisors, Health Personnel and relevant community stakeholders.

The teams shall serve as the body responsible for reporting/addressing the following:

- Strengthening Learning Continuity Mechanisms
- Reinforcing Support to Affected Learners and Personnel
- Restoring and Protecting School Infrastructure
- Improving Disaster Preparedness and Risk Reduction Systems

B. Prepare the Teams' Terms of Reference (TOR)

The teams shall draft a comprehensive TOR that outlines the following:

- Roles and responsibilities of each member
- PFA-related duties
- Learning continuity tasks
- Community participation and coordination mechanisms
- Reporting, communication flow, and monitoring arrangements

The TOR shall emphasize:

- Psychological First Aid (PFA); and
- Learning Continuity with active community involvement.

C. Develop a Schedule of Activities

The teams shall prepare a proposed schedule of activities, covering but not limited to:

- Needs assessment
- PFA deployment

- Community coordination
- Monitoring and reporting
