This is to respectfully request the downloading of additional MOOE funds for **ALL PUBLIC SENIOR HIGH SCHOOL PILOT SCHOOLS** through the issuance of a Sub-Allotment Release Order (Sub-ARO) to the respective schools, and to the School Division Offices (SDOs), in the case of non-implementing units, in the aggregate amount of **ONE HUNDRED THIRTY MILLION FIVE HUNDRED FORTY THOUSAND PESOS ONLY (PHP 130,540,000.00)**.

Please note that the requested amount is chargeable against the contingent funds lodged in the Central Office under the **FY 2024 Continuing Appropriation for Operations of Schools**, and is computed based on school size as of September 2, 2025, with the following breakdown.
