Greetings!

This is to respectfully inform your office that the Regional Juvenile Justice and Welfare Committee VI, through its letter of invitation dated February 23, 2026, had earlier requested your participation in the conduct of on-spot monitoring visits in Bahay Pag-asa and other youth care facilities in the Province of Negros Occidental of the Negros Island Region.

However, the RJJWC VI was unable to proceed with the scheduled monitoring visits due to adjustments necessitated by slight changes in the procurement process. These adjustments, implemented in compliance with austerity measures, consequently caused delays in the rescheduling of the on-spot visits.

In connection with this, the revised schedule of monitoring visits is outlined below to ensure alignment with the Committee's mandate—conducting spot inspections to verify compliance with standards and submit necessary reports and recommendations to the appropriate agencies and to the JJWC.

In line with this, we respectfully invite your focal person to join and assist in the facility visits. The RJJWC VI will provide the vehicle for the visit, while other expenses shall be charged to your agency.
