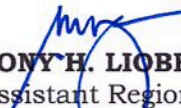

Learning Tools and Equipment (LTEs) delivered to schools by the Department of Education (DepEd) have conventionally been identified based on the competency requirements of existing curriculum guides. As the curriculum continuously evolves to respond to the changing needs of learners, the provision and utilization of LTE likewise require periodic review.

With the implementation of the K to 12 Basic Education Curriculum (2023 Edition) and the Strengthened Senior High School Curriculum, the Bureau of Learning Resources (BLR) shall conduct a Stakeholders' Forum with Regional Supervisors in Science, Mathematics, Technical Professional (TechPro), Music, Arts, Physical Education, and Health (MAPEH), and Learning Resources (LR) from the seventeen (17) regions in the country, as well as selected representatives from suppliers.

The participating regional personnel are supervisors assigned to subject areas or domains that utilize LTEs as integral components of instruction.

The forum explores the following:

1. Issues on the status and utilization of existing Learning Tools & Equipment (LTE) in schools
2. Relevance of LTE to current curriculum competency requirements
3. Conformity of LTE with existing standards
4. Re-examination of LTE needs in public elementary and secondary schools
5. Formulation of monitoring strategies on the utilization of LTE

The outputs of this activity shall be considered in the formulation of DepEd policies relative to the provision, monitoring, and utilization of LTE in public elementary and secondary schools.

The forum shall be conducted on August 11-13, 2026, at the DepEd Ecotech Center, Sudlon, Lahug, Cebu City.

Participants are required to bring their own laptops and download the latest editions of the K to 12 Curriculum Guides for Science, Mathematics, TechPro, and MAPEH from the DepEd website.

Expenses for board and lodging, transportation, and materials of the participants shall be charged against **AC-26-BLR-Cebu-LTE-SME-007** funds, subject to existing accounting and auditing rules and regulations.

The first meal shall be lunch on Day 1 (August 11, 2026), while the last meal shall be lunch on Day 3 (August 13, 2026).
