In support of the Revised K to 10 Curriculum's emphasis on contextualization, interdisciplinary learning, and the development of lifelong competencies and in support of the Five-Point Reform Agenda particularly *Agenda 1 on Invest in Teacher Quality and Equip them with Skills and Resources*, the Office of the Undersecretary for Learning Systems (OULS), through the Bureau of Learning Delivery (BLD) – Teaching and Learning Division (TLD), shall conduct a series of **Workshop Activities on the Development of Environmental Education Integration Lesson Guides**.
